## Objectives and Investment Policy

The aim is to provide a combination of income and investment growth over the long-term.

The Fund is actively managed and is known as a "Fund of Funds" which means that it invests mainly in other investment Funds. These Funds, in turn, invest in a mixture of shares, tradeable debt (bonds), warrants (financial contracts under which the Fund can buy shares at a future date and usually at a fixed price) and money market instruments (a range of short-term financial products which can be easily bought and sold on money markets).

The Funds invested in, invest mainly in medium risk assets worldwide with a

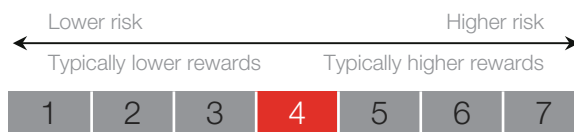
focus on the UK.

The Fund selects other investment Funds to invest in following a thorough review of a broad range of Funds which have been selected using predefined criteria set by the Investment Manager.

Income is not distributed but is rolled up (accumulated) into the value of your investment.

You can buy or sell all or part of your investment on any business day subject to the minimum holding requirements.

## Risk and Reward Profile

This Fund has been measured as 4 because its investments have experienced moderate volatility in the past. The Fund's volatility is affected by various risks, including:

- The Fund will be exposed to stock markets. Stock Market prices can move irrationally and be affected unpredictably by diverse factors, including political and economic events.

- The Fund has significant exposure to bonds, the prices of which will be impacted by factors including; changes in interest rates, inflation expectations and perceived credit quality.

- When interest rates rise, bond values generally fall. This risk is generally greater for longer term bonds and for bonds with higher credit quality.

- The Fund invests in other currencies. Changes in exchange rates will therefore affect the value of your investment.

The Fund may invest a large part of its assets in other Funds for which investment decisions are made independently of the Fund. If these investment managers perform poorly, the value of your investment is likely to be adversely affected. Investment in other Funds may also lead to duplication of fees and commissions.

## Charges

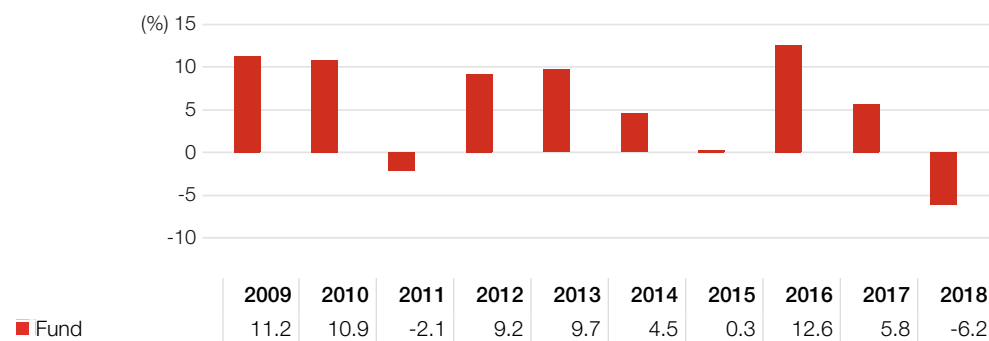
