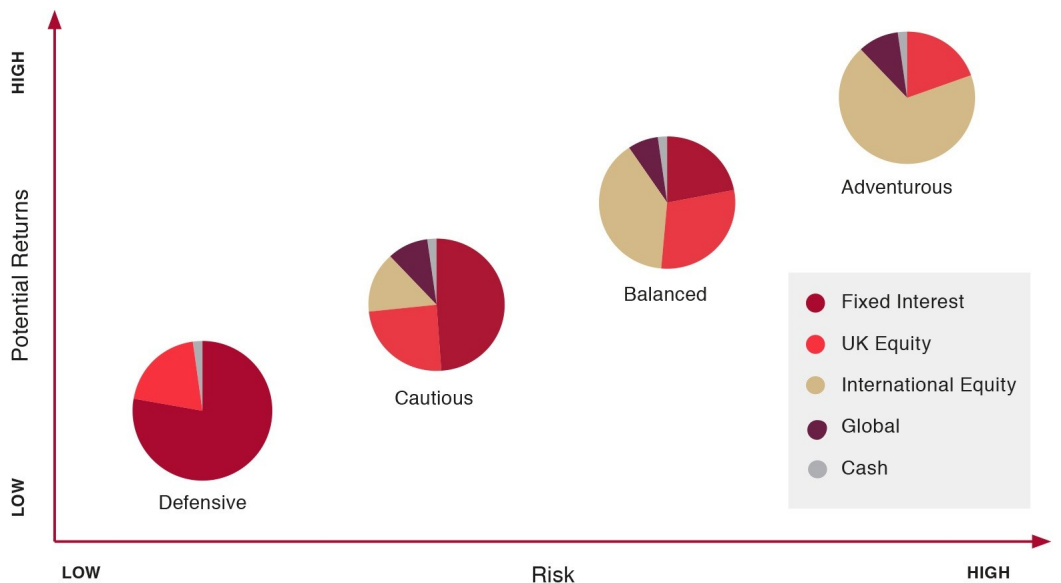

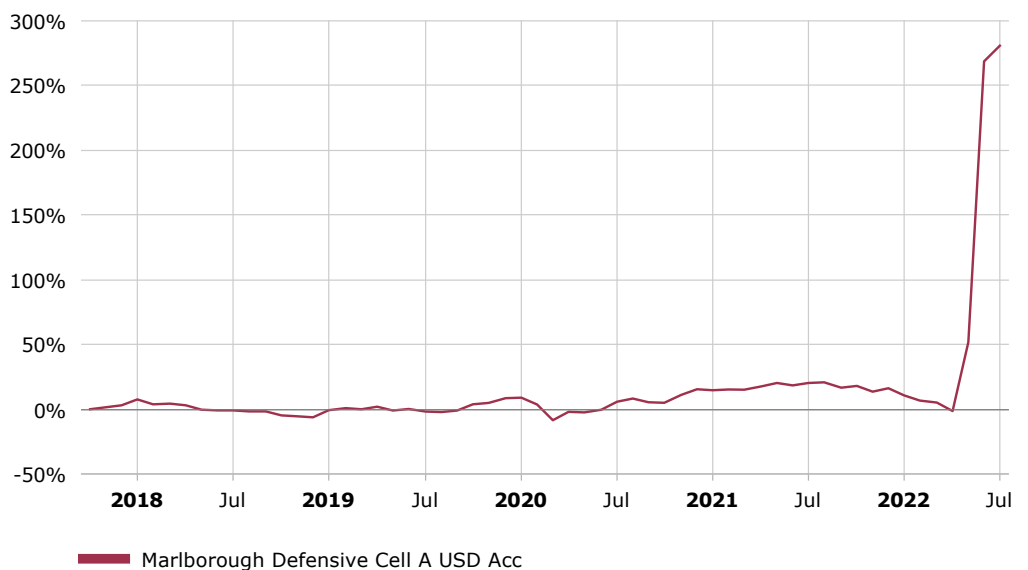
## Four levels of risk Defensive to Adventurous

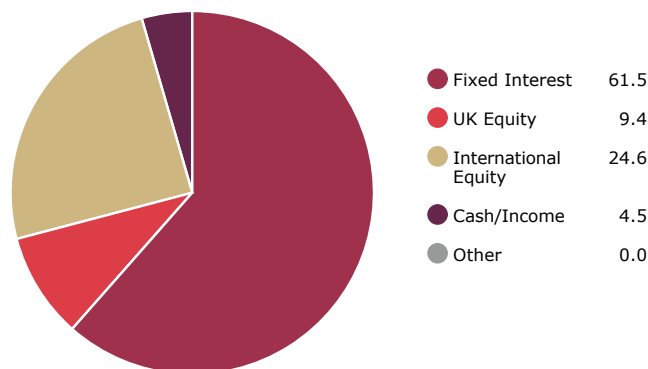
